GENERAL RELEASE AND INDEMNIFICATION – IMPORTANT, PLEASE READ BEFORE SIGNING

In consideration of being allowed to participate in any way in the Texas Gulf Surfing Association (“TGSA”) athletic sports program, including all related events, functions and activities, the undersigned hereby acknowledges and agrees as follows:

[1] The risk of injury from the activities involved in this program is significant, including the potential for permanent injury, paralysis and death;

[2] **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown, **EVEN IF ARISING FROM THE SOLE OR CONCURRENT NEGLIGENCE OF THE RELEASEES** (as defined below), and assume full responsibility for participation.

[3] I, for myself and on behalf of my heirs, executors and personal representatives (and if the parent of a participant, as next friend of and on behalf of my minor child), **HEREBY RELEASE AND AGREE TO INDEMNIFY, HOLD HARMLESS AND DEFEND TGSA**, its officers, directors, officials, agents, volunteers, employees, other participants, sponsors, advertisers and, if applicable, owners and lessors of premises used to conduct the event (referred to collectively as “RELEASEES”), **FROM ANY AND ALL CLAIMS, CAUSES OF ACTION, EXPENSES, DAMAGES AND LIABILITY OF ANY KIND WHATSOEVER, INCURRED OR ASSERTED BY, THROUGH OR UNDER ME (AND, IF A PARENT, MY MNIOR CHILD) FOR PERSONAL INJRY, DISABILITY, DEATH, MEDICAL EXPENSES, LOSS OF OR DAMAGE TO PROPERTY, IMPAIRMENT, LOSS OF EARNING CAPACITY AND ANY AND ALL OTHER CLAIMS, DAMAGES, EXPENSES OR CAUSES OF ACTION WHATSOEVER**, arising from or in any way related to participation in any way in the athletic program of TGSA, attendance or participation in any event activity or function thereof, or any related event, function or activity, including prior to, during or after any such event, function or activity. **WHETHER ARISING FROM THE SOLE OR CONCURRENT NEGLIGENCE OF RELEASEES, OR ANY OF THEM, OR OTHERWISE.**

I ACKNOWLEDGE THAT I HAVE READ THE FOREGOING AND UNDERSTAND ITS TERMS, THAT I UNDERSTAND I AM GIVIING UP SUBSTANTIAL LEGAL RIGHTS BY SIGNING IT, AND THAT I HAVE EXECUTED SAME FREELY AND VOLUNTARILY AND WITHOUT ANY INDUCEMENT OR RELIANCE UPON ANY REPRESETTATION BY RELEASEES.

TGSA SPORTSMANSHIP CODE

SPORTSMANSHIP DEFINED AS THE FOLLOWING:

- The Merriam-Webster Dictionary defines sportsmanship as conduct becoming to one participating in a sport. (Such as; fairness, respect for one's opponent, and graciousness in, winning or losing.)
- The above definition of sportsmanship will be strictly applied to the sport of competitive surfing at all TGSA competitions

UNSPORTSMANSHIP LIKE CONDUCT DEFINED AS THE FOLLOWING:

Surfer is defined as active participant and/or a minor competitor's guardian(s)

- Any surfer who assaults a TGSA official or employee in any way will be suspended from the association for the remainder of the competition year and will lose all individual points that may have been accumulated up to the point of the infraction. Any surfer that causes destruction or damage to property will be subject to immediate suspension from that TGSA event and will lose all individual and team points that have been accumulated at that event.
- A surfer may receive a verbal warning once for the following infractions, upon receiving a second verbal warning, that surfer will be suspended for the remainder of that TGSA event and will lose all individual and team points that may have been accumulated at that event.
- Rude gestures to contest officials and judges
- Swearing at contest officials and judges
- Spitting at contest officials and judges - Ripping up judges sheets
- Writing on judges sheets
- Swearing in official area
- Free surfing in competition area. Any competitors practicing in a designated contest area or causing any other interference with competitors when it is not his/her heat, may be disqualified from the contest, or the next contest, and lose any rating points and team points from that contest
- Taking competition jersey off in water
- Use of illegal drugs in or near the official competition area
- Any and all behavior deemed to be un-sportsmanlike conduct by any two TGSA officials.

APPEALS PROCESS:

- Any surfer who loses his TGSA membership due to the violation of this sportsmanship conduct code may appeal to the TGSA Board of Directors. Upon review, the Board's decision will be final.
